



Earn Early-Bird Bonus Points Toward Health Rewards

Act By March 31, 2015.

Your Health.



Act fast and you can earn bonus points toward health rewards.

- Earn **50 points** for taking the voluntary health questionnaire early, by **March 31, 2015**.
- Earn **20 points** for taking the voluntary health questionnaire for the first time, ever.
- Earn **20 points** if you've taken the questionnaire before and your wellness score improves over your prior year's score.

Earn points toward health rewards.

If you want to earn points towards health rewards in 2015, start by completing the [voluntary health questionnaire](#) (even if you took it last year).** After you take the questionnaire, participate in qualifying wellness activities to earn points toward health rewards. You must accumulate **250 points by October 31, 2015**, to qualify. In 2015, health rewards include a **\$250 Wellness Credit** added to your Health Care Spending Account on January 1, 2016,[†] and entry into a drawing for a chance to **win free medical premiums** for all of 2016 for you and your eligible dependents.

Take the voluntary health questionnaire again.

Year after year, our lives and our health risks change. Taking the voluntary health questionnaire *each year* is one way to assess those risks and changes.

- The questionnaire is **confidential**.*
- It takes less than **15 minutes**.
- You may complete it from your **computer or smartphone**.
- The health questionnaire is voluntary, but if you want to qualify for **health rewards**, you're *required* to take the questionnaire before you can start earning points.**

Go to hr2.chevron.com/wellness to get started or to learn more about health rewards including eligibility rules and a list of qualifying activities. Remember, to qualify for health rewards you need to take the health questionnaire *and* earn 250 points by October 31, 2015.**

*Only you, WebMD, Chevron health care plans, and certain third party health care plan vendors will have access to your individual health questionnaire results.

**U.S.-payroll employees who are eligible for Chevron's health plans can qualify for health rewards. In addition you must still be an eligible employee on January 1, 2016, to receive the health rewards. The health questionnaire is completely voluntary, but if you want to earn health rewards, you're required to take the questionnaire before you can start earning points. Only you, WebMD, Chevron health care plans, and certain third party health care plan vendors will have access to your individual health questionnaire results. † If you enroll in the High Deductible Health Plan (HDHP) and you meet the requirements to qualify for health rewards, your Wellness Credit will be deposited into a Limited Purpose Health Care Spending Account (LHCSA) on January 1, as long as you're still eligible. The LHCSA may only be used to pay for eligible dental and vision expenses you incur between January 1 and December 31, 2016.
