This change applies to medical services with Anthem under the Chevron Medical PPO Plan, HDHP and HDHP Basic.

about the service

Effective January 1, 2026, Chevron has partnered with Catapult Health to provide participants enrolled in Anthem medical coverage with access to **VirtualCheckup[®]**, a virtual preventive health screening program that's completed from the comfort of home. This new service is an *additional* option to receive an annual preventive health check-up under your Chevron medical coverage and includes:

- **A simple at-home health screening kit** so you can collect a blood sample, your blood pressure, and other physical measurements from home.
- **A health questionnaire** to gather your current and past health history, symptoms, and medications – similar to the kinds of information gathered at an in-person appointment.
- **A live video consultation** with a board-certified Nurse Practitioner to discuss the results of your screening and health questionnaire.
- **A written personalized plan** with suggestions to help you improve or maintain your health, including referrals to Chevron-sponsored health programs or other recommended follow-up health appointments.
- **Your results can be shared** with your primary care provider through secure transmission, if desired.

VirtualCheckup with Catapult Health is automatically included as an *additional* service option under your Anthem medical plan's current **Preventive Care** coverage; traditional in-office preventive care visits have not been eliminated and continue to be available.

- Your plan covers one VirtualCheckup per enrolled participant, per calendar year.
- VirtualCheckup is covered at 100% with no deductible or coinsurance.
