open enrollment follow-up

- ✓ **If you continue coverage with your current health plan next year, use your existing ID card *unless* you receive a new one.**



All participants enrolled in a medical plan with Anthem will receive a new ID card for use starting January 1, 2026.



All participants enrolled in a medical plan with Cigna will need to download a new ID card for use starting January 1, 2026.

- ✓ **If you switched to a different health plan choice or started participating in Chevron health coverage, a new ID card will be issued.**

ID cards are typically issued in December. Use the new card for services on or after January 1.

- ✓ **If at any time you receive a new ID card, follow instructions regarding its use and show the new card to your provider(s) when you receive services.**

This will ensure your claims are processed properly.

- ✓ **Special purpose debit cards for the Health FSA and Fidelity HSA function just like your personal bank debit card.**

If you remain enrolled in either of these accounts, you can continue to use the card year-to-year until it expires; you'll receive a new card prior to expiration. If you've enrolled for the first time, you will receive your debit card(s) in December.

chevron ID card and website information

Not every Chevron health plan will issue an ID card. Here's what to expect from your plan.

Anthem

Medical and behavioral health services under the Medical PPO, HDHP and HDHP Basic

- ID card(s) are issued in the mail.
- Use this card for medical and behavioral health services; *does not* apply to prescription drugs or basic vision
- Access [Anthem website and/or app here](#). You'll need your Member ID from your card to access digital ID cards online.

Express Scripts

Prescription Drugs under the Medical PPO, HDHP and HDHP Basic

Prescription Drugs obtained inside the U.S. under the Global Choice Plan

- ID card(s) are issued in the mail.
- You *must* present this ID card for retail pharmacy benefits in the U.S.; *does not* apply to medical, behavioral health or vision.

Kaiser

Medical, behavioral health, and basic vision services under the Medical HMO Plan

- ID card(s) are issued in the mail.
- Access [Kaiser website and/or app here](#).
- **Contact Kaiser** for assistance.

VSP Vision Services

- **Vision Plus Program**
- **Basic vision** under the Medical PPO, HDHP, HDHP Basic and Global Choice Plans

- You do not need an ID card; simply tell your provider that you have coverage under VSP.
- If you still want an ID card, login to your account on the [VSP website](#) and print one.
- **Contact VSP** for assistance.

Cigna

Global Choice Plan

- *All* medical, behavioral health services, both inside and outside U.S.
- Prescription drugs obtained *outside* the U.S.

- An ID card will not be mailed to you. All ID cards are digital *only*.
- Digital ID card(s) are available from the [CignaEnvoy website or mobile app](#).
- **Contact Cigna** for assistance.

Delta Dental

Dental PPO Plan

- You do not need an ID card; simply tell your provider that you have coverage under **Delta Dental of California** and provide your **Name**, **Date of birth**, **Employer Name**, and **Enrollee ID** number (or **social security number**). If you have enrolled dependents, tell them to provide *your* details, not their own.
- **Enrollee ID:** Your social security number can be used to identify you, but your Enrollee ID is a safer choice. It's available from the [Delta Dental website](#) on your digital ID card or by calling Delta Dental.
- If you still want an ID card, login to your account on the [Delta Dental website](#) and print one.
- **Contact Delta Dental** for login or Enrollee ID assistance.

DeltaCare USA

Dental HMO Plan

- When you enroll for the first time, you will receive a package in the mail from DeltaCare containing your **primary care dentist name**, your **Enrollee ID**, an **ID card**, and instructions for changing the **primary care dentist** auto assigned to you. You must use your primary care dentist to receive plan benefits.
- **Enrollee ID:** Your social security number can be used to identify you, but your Enrollee ID is a safer choice. Your ID will be included in your mailed package.
- Login to your account on the [DeltaCare USA website](#) for a digital ID card.
- **Contact DeltaCare USA** for login or Enrollee ID assistance.

chevron ID card and website information (continued)

Fidelity HSA

- You will receive a special purpose debit card for your account. You can continue to use the card year-to-year until it expires; you'll receive a new card prior to expiration.
- **First time?** Remember, you *must* have consented to open your account from the BenefitConnect website when you first enrolled in Chevron HDHP or HDHP Basic.
 - Watch for subsequent communications from Fidelity HSA; provide any additional information needed to complete your account opening, if necessary.
 - When your account is open, Fidelity will send an email to you with information about how to activate your HSA on [Fidelity NetBenefits](#). Account opening and activation is a one-time process.
 - You will receive your HSA debit card from Fidelity HSA when your account is open, activated, and ready to use.
